

Will Antigua & Barbuda use sustainable fuel for power generation?

The island of Antigua and Barbuda has taken the lead in utilising environmentally sustainable fuel for power generation, and this will be the first project of its kind in the Eastern Caribbean region where an LNG terminal will be coupled to a Wärtilä power plant.

What is Wärtilä energy's EPC agreement with Antigua?

Mr Francis Hadeed, Director, APCL (on the right) and Rodney George, VP Caribbean, Wärtilä Energy, signed EPC agreement for a 46 MW power plant delivery to Antigua in November 2021. Wärtilä will supply and install a 46 MW dual-fuel power plant to the Caribbean Island of Antigua. The plant will operate with five Wärtilä 34DF engines.

What will the LNG fuel terminal do in Antigua?

The LNG Fuel Terminal will power a 40 MW LNG Power Plant in Antigua that will provide an additional supply of power to the electrical grid. The project is expected to be completed by the end of 2022.
