What does Gibson Energy do?

Gibson Energy Inc. is a midstream oilfield service company in the oil and gas industry. The Company operates facilities and infrastructures such as injection stations, terminals, pipelines, tank storage, and a fleet of truck transportation units. Gibson Energy also provides retail propane service.

When did Gibsons buy Omni Energy Services?

Gibsons was sold by Hunting plc to an energy industry focused private equity fund managed by Riverstone Holdings in December 2008, for C\$1.2 billion. It was later listed on the Toronto Stock Exchange on June 14, 2011. In 2012, Gibson bought Omni Energy Services for \$445 million.

Is Gibsons a Canadian company?

Gibsons is a Canada-based midstream oilfield service company in the oil and gas industry. Its assets include pipelines, oil storage facilities, as well as a refinery in Moose Jaw. It is listed on the Toronto Stock Exchange. Gibsons was founded with the incorporation of its predecessor in 1953.

Where is Gibsons oil & gas based?

It also runs a number of oil storage terminals, the largest of which is the Hardisty Terminal in Hardisty, Alberta. Gibsons used to run a trucking service to haul petroleum and other products from and to oil and gas production facilities.

Is Gibsons a subsidiary of Hunting plc?

It was initially a subsidiary of Hunting plc, a British firm in the same business. Gibsons was sold by Hunting plc to an energy industry focused private equity fund managed by Riverstone Holdings in December 2008, for C\$1.2 billion. It was later listed on the Toronto Stock Exchange on June 14, 2011.
