Offshore services provider OEG Energy Group has invested a seven-figure sum in a new Aberdeen HQ after increasing its headcount by 300 in a year of "exceptional growth". The move into a new global headquarters on ABZ Business Park in Dyce is said to mark a significant milestone in the group's 50-year history.
