What is Energos infrastructure?

New Fortress Energy (NFE) and Apollo have announced the creation of a new \$2bn liquefied natural gas (LNG) maritime platform called Energos Infrastructure. Formed as part of a previously announced joint venture (JV), Energos is the owner and operator of 11 LNG infrastructure vessels.

What is Energos?

Energos is a global marine infrastructure platform underpinned by long-term contracts, benefitting from NFE's LNG downstream operations and development activities, as well as Apollo's leading investment and maritime experience.

Who owns Energos infrastructure?

The Platform has been named Energos Infrastructure ("Energos") and is owned approximately 80% by Apollo-managed funds and 20% by NFE. This press release features multimedia.
