

Is there a Cooperation Programme between the European Union and Eritrea?

Currently, there is no established cooperation programme between the European Union and Eritrea. Relations between Eritrea and the European Union go back to the first years of Eritrean independence. The European Commission opened its Delegation in Asmara in 1995.

Does the EU support Eritrea?

The EU has supported Eritrea since its independence in 1991. This support has covered a range of areas in the past such as agriculture and food security and governance while the last cooperation programming has shifted focus to also include the issue of energy production.

Is Eritrea cooperating with the EU?

As regards Eritrea-EU development cooperation, the European Development Fund (EDF) used to be the main EU instrument for development cooperation with ACP countries, including Eritrea. Currently, there is no established cooperation programme between the European Union and Eritrea.

Is Eritrea a developing country?

Eritrea is classified as a Least Developed Country (LDC) under the list established by the Committee for Development Policy (CDP) of the UN Economic and Social Council (ECOSOC). Eritrea's economy suffered serious setbacks, which the country is currently trying to address.

What is Eritrea's economy based on?

Reasonable estimates indicate that Eritrea's economy is largely based on agriculture, including a significant portion of subsistence agriculture, a rapidly developing mining sector with large-scale foreign investments, and a small manufacturing sector. Mining, fisheries, agro-processing, and tourism are sectors with considerable untapped potential.

Is there a bilateral envelope for Eritrea?

Currently there is no bilateral envelope for Eritrea. The EUDEL to Eritrea is managing 28 contracts funded through thematic instruments (Civil Society Organisations, Human Rights & Democracy) and Regional Technical Cooperation Facility. (TCF). The total value of the portfolio is around MEUR 12. Sector wise, the projects can be grouped as follows;
