Why did Svevind energy get a partnership with Semurg invest?

One core element for this is the signed cooperation agreement with Semurg Invest, the owner and operator of the largest terminal facility of the port of Kuryk on the Caspian Sea. Another milestone was reached just before year ended as SVEVIND Energy received confirmation that Germany is backing our project with an so called investment guarantee.

How does Svevind AB manage a wind farm?

Svevind AB establishes a subsidiary for the project, which is then responsible for project planning. Construction and ownership may also be through Svevind AB's subsidiaries. Once the wind farm has been approved, Svevind AB or the relevant subsidiary may sell all or part of the project, or retain it for its own construction and operation.

Why did Svevind energy buy Markbygden net?

In order to drive this process forward as effectively as possible, SVEVIND Energy divested the grid company „Markbygden Net" operating Sweden's most powerful substation, the 1700 megawatt substation R&#229;backen and related grid infrastructure to the Nordic grid operator Ellevio.

How does Svevind design a wind farm?

o Svevind identifies suitable locations with regard to favourable wind conditions, grid connection capacities, the absence of conflicting interests and rural development opportunities. The design of the wind farm is then planned and the documentation produced for the permit application.
