The project was developed and funded entirely by AGR and sold to Octopus Energy in 2021 at RTB status. AGR did not sign an EPC contract for the delivery of the asset. Breach solar farm is currently in construction ...

The total cost of acquisition and development is expected to reach £50m. AGR was retained to provide support during the construction and integration phase.
