What does Neoen do?

Neoen develops, finances, builds and operates solar plants, wind farms and storage facilities representing several gigawatts in total, on 4 continents.

What markets does Neoen operate in?

Neoen operates in the solar power, onshore wind farm and battery storage markets. Its turnover for 2023 was EUR524.4 million, made up of 41% solar power (EUR213.7 million, an increase of 10% year on year), 48% wind power (EUR251.2 million, 16% increase) and 11% storage (EUR58 million).

What happened to Neoen?

In 2019, Neoen sold its only biomass unit and continued its international expansion, with an agreement to provide wind power for Google in Finland and the financing of a 375-MWp solar park in Mexico providing energy at US\$18.93 per MWh. That year, the company reached the milestone of 1 GW of assets in Australia alone.
