What is 'rooftop solar scheme' & 'pm Surya Ghar muft Bijli Yojan'?

The Finance Minister, Nirmala Sitharaman, announced the launch of the 'Rooftop Solar Scheme' or the 'PM Surya Ghar Muft Bijli Yojana' in the Interim Budget 2024-25. In the full Budget 2024-25, the Finance Minister reiterated that this scheme will enable 1 crore households to obtain free electricity up to 300 units every month.

What is rooftop solar Yojana?

The Rooftop Solar Yojana, or the PM Surya Ghar Muft Bijli Yojana, aims to provide 300 units of free electricity every month to light up one crore households. The objective of this scheme is to reduce the electricity costs of the house by installing rooftop solar panels and using solar energy.

Central Financial Assistance (CFA) for Residential Rooftop Solar. The PM-Surya Ghar Muft Bijli Yojana provides a CFA of 60% of system cost for 2 kW systems and 40% of additional system cost for systems between 2 to 3 kW capacity. The CFA will be capped at 3 kW. At current benchmark prices, this will mean Rs 30,000 subsidy for 1 kW system, Rs ...
