Once up and running, it will increase the capacity of the Toco energy storage complex to 19.3 MW/25.6 MWh. Voltalia noted that Sable Blanc benefits from a 20-year guaranteed tariff. At present, Voltalia operates 31 MW of solar, hydro, biomass and storage power plants in French Guiana, covering close to 10% of the main electricity grid consumption.

At present, the French firm owns three solar, two biomass and one hydropower plant in French Guiana, plus some 30 MW of energy storage facilities. Last November, Voltalia commissioned the 10-MW/13.6-MWh Mana battery facility that will be part of the Toco storage complex in French Guiana.
