How can solar power help New Zealand?

Can a three phase solar system import and export energy?

With a three phase solar system there may be instances when you will import energy on one phase while exporting energy on another phase. This is because all three phases operate independently of one another. You may want to ask your installer to check the loading on each phase as part of the installation process.

Can a solar energy system save you money?

If you have excess electricity, you can sell it back to your power company and lower your power bill. If you don't produce all of the power you consume, you will still reduce your power bill and save money. Also, it's likely that the price of electricity will rise, so a solar energy system will save you money in future.

Can Contact Energy install a solar meter?

Contact Energy advises that for customers looking to set up a solar system, it can install an import/export meter for either less or greater than 10kW output. Customers can apply via Contact's website. Buy-back rate: Customers will see the amount of distributed generation they're selling on their electricity bill, where applicable.
